I give my legal and lawful heirs them, sharing equal at my wife's death my said wife is to have full control of my personal estate to manage any and all claims due me. I do hereby revoke all former wills by me made. In witness whereof I have hereunto set my hand and Seal this 15th day of September A. D. 1871.
